

NPSA MEMBERSHIP APPLICATION

NPSA Membership consists of two categories: Sheller and Affiliate.

Sheller- Any individual, partnership, corporation or association engaged in shelling pecans, whose application is approved by the Board of Directors, may become a sheller member.

Affiliate- Any individual, partnership, corporation or association not engaged in shelling pecans, but having an interest in the pecan shelling and processing industry, whose application is approved by the Board of Directors, may become an Affiliate member.

Application Process:

- After a completed application is received by NPSA, a preliminary review will be conducted by the NPSA Membership Coordinator to ensure all needed information is received.
- After preliminary review, the application will be forwarded to the NPSA Board of Directors for a vote.
- Once the Board approves membership, new members will receive a Welcome Letter and Invoice for first year's dues.
